- 1. The above Unaudited results were reviewed by the Audit Committee and were taken on record by the Board of Directors at their meeting held on December 14, 2016
- 2. It is difficult to identify segment wise profitability and capital employed considering that Infrastructure is common for all the revenue activities of the Company.
- 3. The Company has adopted Indian Accounting Standards (Ind AS) from Apr 1, 2016 and accordingly the above financial results have been prepared in accordance with the principles laid down therein. Based on SEBI Circular CIR/CFD/FAC/62/2016 dated July5, 2016, the Company has presented the figures for the corresponding quarter ended and six months ended September 30,2015 and the reconciliation of the net profits for the corresponding period is as under:


